6. Research in Progress

- 1) Reforming Red Armies: Explaining Postcommunist Military Reform: Book Project (2024-present)
 - This is a new project that I have been developing for the past two years. This project examines the role of military culture, national identity, and democratic values, as well as the Russian threat, in influencing postcommunist military reform, particularly the effective adoption of NATO military standards and implementation of international norms of military conduct and just war. The project builds on my experience working in Kyrgyzstan on the Partnership for Peace program with NATO in the 1990s.
 - I have made several field research trips to Estonia, Latvia, Lithuania, Hungary, Poland, Romania, and Georgia, as well as Kyrgyzstan. I will be in Poland, Estonia, and Kazakhstan on a Fulbright Global Scholar Award in 2026-2027.
